Communications: Board members received a copy of the monthly Police report.

Trustee Bogacz wanted the President and board to know that she did look into the grant application. There is funding available for non-motorized projects which would be an 80/20 match. Some projects had to have Phase I engineering done to submit the application. There just wasn't enough time available to do this application. She will be more involved in looking into these grants. President Counley will give another call into PACE to see how the bus stop is progressing. There is help for the elderly and disabled for gas and electric bills through the MC Housing Authority that will be put in our newsletter.

All Sports Bar & Grill: As of this moment the verbal agreement from the Administrative Hearing on August 26, 2013 with the owner for access to the video tapes and a copy of the personnel policy concerning bar fights has not been complied with. Attorney Shaw has spoken with the bar owners attorney and the owner has thirty (30) days to appeal. The courts will review it to make sure the defendant did have due process. The comments that were made to the Northwest Herald by the bar owner were unprofessional. Attorney Shaw received the audio tape of the hearing from Clerk Messina which he will forward it to Gaylen's attorney and the judge. We did everything we could per our Ordinance on this we will probably be served a subpoena in 14 days. President Counley needs to tell him the days that he will be suspended which has been decided that it will be a Wednesday and Thursday until we are told by the courts we can't. The bar owner has never lived up to his end. Attorney Shaw will have to have an injunction issued on the suspension and if they choose to ignore it the liquor license will be revoked. All the board members agree with the suspension being on a Wednesday and Thursday.

New Business: Annual Treasurers Report - Trustee Matthesius made a motion to approve the Annual Treasurers Report for the fiscal year ending March 31, 2013; seconded by Trustee Shepit. Voice vote: Bogacz, Fritz, Glave, Matthesius, Shepit, Walter=ayes. All in favor, motion carried.
