A. CHANGES TO BEST MANAGEMENT PRACTICES

There are no changes to the Best Management Practices for the six minimum control measures as submitted in the latest NOI for the Village of McCullom Lake and as noted in the year 17 Annual Facility Inspection Report as described in Part B of this Report – Status of Compliance with Permit Conditions.

B. STATUS OF COMPLIANCE WITH PERMIT CONDITIONS

The Village of McCullom Lake committed to various Stormwater BMP's to meet the requirements of the NPDES Phase II Stormwater Program. Following is a status report of the BMPs and the activities undertaken during year 17.

1. PUBLIC EDUCATION AND OUTREACH

BMP A.1 DISTRIBUTED PAPER MATERIAL

• Goal: The Village of McCullom Lake continues to make a Stormwater information brochure available to residents at the Village Hall. The Village also distributes it to residents with the Village newsletter. The brochure addresses and describes the impacts of polluted Stormwater discharges on water bodies, the steps that the public can take to reduce pollutants in Stormwater discharges, and the hazards associated with illegal discharges and improper waste disposal. It also includes a contact number that residents can use to report Stormwater related issues.

• Milestones: Continue to make available and distribute brochure.

Make available information regarding rain barrels, bio swales and rain gardens.

2. PUBLIC PARTICIPATION INVOLVEMENT

BMP B.7 PUBLIC REPORTING

• Goal: Inform all residents of the existence of contact number by including it in utility bills semi-annually and in informational brochure discussed in BMP No. A1. The contact number can be used by residents to report Stormwater related issues including ordinance violations, maintenance issues and illicit discharges.

Also continue to pursue grant funding for future storm water collection system improvements within the Village.

- Goal: continue to work with the State of Illinois to obtain grant funding to reconstruct McCullom Lake Road roadway and drainage system.
- Milestones: Future STP funding through McHenry County authorized for McCullom Lake Road drainage.

3. ILLICIT DISCHARGE DETECTION AND ELIMINATION

BMP C.1 SEWER MAP PREPARATION

- Goal: Continue to update the overall storm sewer map of the Village of McCullom Lake
- Milestones: Map remains the same with no updates

BMP C.3 <u>DETENTION PLAN</u>

- Goal: Provide monthly site inspections of the northern commercial/industrial area of the Village.
- Milestones: Village has created Erosion and Sediment Inspection Form to log erosion and sediment control items.

- Goal: The Village of McCullom Lake has adopted the McHenry County Stormwater Management Ordinance in its entirety. This ordinance regulates Erosion and Sediment Control procedures, site plan review, site inspection and the enforcement of these issues.
- Milestones: Continue to implement the enforcement of the McHenry County Stormwater Management Ordinance, and monitor and inspect future drainage construction improvements.

5. POST-CONSTRUCTION RUNOFF CONTROL

BMP E.2 REGULATORY CONTROL PROGRAM

- Goal: The Village of McCullom Lake has adopted the McHenry County Stormwater Management Ordinance in its entirety. The County wide ordinance addresses post-construction runoff from new development and redevelopment projects. The ordinance requires the implementation of controls to prevent or minimize water quality impact, the installation of structural or non-structural BMP's over the life of the development.
- Milestone: Continue to enforce the McHenry County Stormwater Management Ordinance. Continue to inspect and monitor recent construction projects containing soil and erosion control measures.

6. POLLUTION PREVENTION/GOOD HOUSEKEEPING

BMP F.2 INSPECTION AND MAINTENANCE PROGRAM

- Goal: The Village of McCullom Lake currently conducts an inspection and maintenance program designed to reduce pollutant runoff from municipal operations. Storm sewers and catch basins are cleaned on an as needed basis or as requested by residents. Homeowners maintain ditches located on their property. The inspection and maintenance program has been effective to date.
- Milestones: Evaluate effectiveness of Inspection & Protection Program

BMP F.3 <u>MUNICIPAL OPERATIONS STORM WATER CONTROL</u>

- Goal: The Village of McCullom Lake has no public works department and keeps all vehicles at the Village Hall. All vehicle maintenance is contracted out by the Village. The Village stores no chemicals or road salt and performs few activities that require pollutions preventions measures.
- Milestones: Monitor existing policies.

C. RESULTS OF INFORMATION COLLECTED AND ANALYZED

No monitoring data was collected and analyzed during the year 17 reporting period.

D. SUMMARY OF ANTICIPATED ACTIVITIES DURING THE NEXT REPORTING CYCLE

1. PUBLIC EDUCATION AND OUTREACH

BMP A.1 DISTRIBUTED PAPER MATERIALS

The Village of McCullom Lake will continue to make its Stormwater information brochure available to residents at the Village Hall. The information is also included in utility bills. The village will also make available on its website information on rain barrels, bio swales and rain gardens.

2. PUBLIC PARTICIPATION/INVOLVEMENT

BMP B.7 PUBLIC REPORTING

The Village of McCullom Lake will continue to provide a contact number that residents can use to report Stormwater related issues, including ordinance violations, construction site soil erosion/sediment control violations, maintenance issues and illicit discharges.

3. ILLICIT DISCHARGE DETECTION AND ELIMINATION

BMP C.1 SEWER MAP PREPARATION

The Village will work on expanding the details and information on the recently complete storm sewer map and provide an ultimate Village storm sewer collection system. This will assist in future Stormwater maintenance and control, and also in the Village's ongoing pursuit of funds for needed storm sewer improvements.

BMP C.3 DETENTION PLAN

The Village will perform monthly site inspections of northern commercial/industrial area of the Village.

4. CONSTRUCTION SITE RUNOFF CONTROL

BMP D.1/D.2/D.3/D.4/D.6 SOIL EROSION AND SEDIMENT CONTROL ORDINANCE

The Village of McCullom Lake has adopted the McHenry County Stormwater Management Ordinance in its entirety, and will continue to enforce all provisions.

5. POST-CONSTRUCTION RUNOFF CONTROL

BMP E.2 REGULATORY CONTROL PROGRAM

The Village of McCullom Lake has adopted the McHenry County Stormwater Management Ordinance in its entirety. The county wide ordinance addresses post-construction Stormwater runoff from new development and redevelopment projects. The Village will continue to enforce the Ordinance.

6. POLLUTION PREVENTION/GOOD HOUSEKEEPING

BMP F.2 INSPECTION & MAINTENANCE PROGRAM

The Village of McCullom Lake currently conducts an inspection program designed to reduce pollutant runoff from municipal operations. Storm sewers and catch basins are cleaned on an as needed basis or as requested by residents. Homeowners maintain ditches located on their property. This maintenance program will be formalized and evaluated on a biennial basis to determine its effectiveness.

The Village will conduct periodic visual monitoring of the storm water at the catch basin located near Village Hall following heavy rainfall. The McHenry County Department of Health samples the beach water approximately eight times between the months of May through August.

E. RELIANCE ON ANOTHER GOVERNMENTAL ENTITY

The Village of McCullom Lake is not relying on another government entity to satisfy its permit requirements.

F. CONSTRUCTION PROJECT LIST

No Village of McCullom Lake drainage improvements project were completed during the March 2019 to March 2020 reporting period.
